The Convention takes place at LAV – LISBOA AO VIVO, on the 5th, 6th, 7th and 8th of October 2023, Thursday (holiday), Friday, Saturday and Sunday)

REGISTRATION: Registration is open and must be done through the website <a href="www.lisbontattoorockfest.com">www.lisbontattoorockfest.com</a> The registration system is very simple and all fields are mandatory. In the absence of any data, the system itself rejects the registration.

Pay attention to the maximum size of the photos. If they exceed the size, they cannot be loaded.

After receiving the registration, if it is accepted, you will receive an email with the confirmation of the same and with the data to make the respective payment.

REGISTRATION IS ONLY CONSIDERED VALID AFTER PAYMENT RECEIVED. Registration is reserved for 100% professional studios that comply with current legislation and good practices in the area.

## **AVAILABLE STAND TYPE:**

- -A tattoo stand (2 tattooists + 2 helpers) is 3x3 meters 4 chairs and a common front table.
- Half stand (1 tattoo artist + 1 helper) measures 1.50 x 3 meters, 2 chairs and a common front table.

THE HALF STAND IS A STAND SHARED WITH ANOTHER TATTOO ARTIST / STUDIO. Tattoo stands include light, electrical outlet, garbage and waste collection. - Supplier stand (4 people) – Reserved for companies that sell tattoo material and derivatives. 3x3 meters 4 chairs and a common front table.

## **GENERAL RULES:**

- All spaces and stands must be fully operational during the hours when the event is open to the public. No visitor will want to see your stand empty.
- The placement of any and all types of advertising for products and services that have not been previously communicated and approved by the LTRF organization or that in any way collide with advertising obligations assumed by the organization is not allowed.

- It is not allowed to sell items or products in the stands that have not been previously communicated and approved by the LTRF organization
- It is not allowed to do Piercing, Scarefication, Branding etc in the stands. Only tattoo is duly authorized.
- All stands / tattoo artists are legally responsible for the services provided.
- All stands / tattoo artists must have the necessary documentation to prove the legality of their professional activity in case of inspection. Required by law.
- All stands / tattoo artists must have a manual or electronic billing system as well as a complaints book. Required by law.
- The minimum tattoo price to be practiced at LTRF is €50. no work can be charged below this amount. Art has to be valued, tattoo artists must value their art and work and, in turn, educate the customer to look for quality and not price.

Following this philosophy, we alert all suppliers to the need to maintain price consistency, not tolerating any type of price variation during the event based on the prices of competing suppliers.

- All rules imposed by the DGS and other entities relating to COVID 19 must be fully complied with, with tattoo artists responsible for the use of all personal protective equipment.

ANY STAND OR EXHIBITOR THAT DOES NOT COMPLY WITH THE POINTS REFERRED TO WILL BE PENALIZED, MAY BE EXCLUDED FROM THE EVENT AND PREVENTED FROM REGISTERING IN FUTURE EVENTS WITH NO REFUND.
