

## **GENERAL CONDITIONS FOR PARTICIPATION IN THE LISBON TATTOO ROCK FEST LISBON INTERNATIONAL TATTOO CONVENTION 2024**

- The Convention takes place at LAV – LISBOA AO VIVO, on the 4th, 5th and 6th of October 2024, Friday, Saturday and Sunday)

- **REGISTRATION:** Registration is open and must be completed via the website [www.lisbontattooockfest.com](http://www.lisbontattooockfest.com) The registration system is very simple and all spaces are mandatory. If any data is missing, the system itself rejects the registration. We ask for your attention to the maximum size of the photos. If they exceed the size, they cannot be loaded.

All applications are subject to approval. After receiving the registration, if it is accepted, you will receive an email confirming it and with the details to make the respective payment.

REGISTRATION IS ONLY CONSIDERED VALID AFTER PAYMENT RECEIVED.

Registration is reserved for 100% professional studios that comply with current legislation and good practices in the area.

### **- TYPE OF STAND AVAILABLE:**

- **A tattoo stand (2 tattoo artists + 2 helpers)** is 3x3 meters, 4 chairs and a front table.

- **Half stand (1 tattoo artist + 1 assistant)** is 1.50 x 3 meters, 2 chairs and a shared front table.

ATTENTION: THE HALF STAND IS A STAND SHARED WITH ANOTHER TATTOO ARTIST / STUDIO.

All tattoo stands include lights, electrical outlets, rubbish and waste collection.

- **Supplier stand (4 people)** – Reserved for companies reselling tattoo supplies and derivatives. 3x3 meters 4 chairs and a common front table.

ATTENTION: - Each tattoo artist will be presented with the name indicated in the registration. It will also be associated with the name of the studio that appears on the form. We will not make changes to the presentations of tattoo artists that have not taken this into account.

### **GENERAL RULES:**

- All spaces and stands must be fully operational during the hours when the event is open to the public. No visitor will want to see your stand empty.

- It is not permitted to place any and all types of advertising for products and services that have not been previously communicated and approved by the LTRF organization or that in any way conflict with advertising obligations assumed by the organization.

- It is not permitted to sell items or products on stands that have not been previously communicated and approved by the LTRF organization

- Piercing, scarification, branding, etc. are not permitted on the stands. Only tattoos are duly authorized.

- All stands/tattoo artists are legally responsible for the services provided.

- All stands/tattoo artists must provide themselves with the necessary documentation that proves the legality of their professional activity in the event of inspection. Required by law.

- All stands/tattoo artists must have a manual or electronic invoicing system as well as a complaints book. Required by law.

- The minimum price for a tattoo to be practiced at LTRF is €50. No work can be charged below this amount. Art has to be valued, tattoo artists must value their art and work and in turn educate the client to look for quality and not price. Following this philosophy, we alert all suppliers to the need to maintain price consistency, with no type of price variation tolerated during the event based on the prices of competing suppliers.

- All rules imposed by the DGS and other entities relating to COVID 19 must be fully complied with, with tattoo artists being responsible for using all personal protective equipment.

ANY STAND OR EXHIBITOR THAT DOES NOT COMPLY WITH THE REFERENCED POINTS WILL BE PENALIZED, MAY BE EXCLUDED FROM THE EVENT AND PREVENTED FROM REGISTERING FOR FUTURE EVENTS, WITH NO REFUND.
